
You are hereby cordially informed that the validity period for the above-mentioned bid has been further extended to the 23<sup>rd</sup> August 2021.

The closing date for the submission of the above-mentioned bid was 23<sup>rd</sup> March 2021, with a validity period of 90 days from the closing date. A process of requesting forty five (45) bidders to accept the extension will be followed which is in line with Provincial Treasury SCM Instruction Note 1 of 2020/2021: Application of Bid Validity. Forty five (45) bidders were requested to return the form for extension of validity period on or before the 20<sup>th</sup> July 2021, therefore only twenty two (22) bidders responded for extension of validity period. However it was indicated in the form that if the bidder did not respond within the stipulated period it is assumed that they agree with the extension.
